#### **PDC / Safety Conferences**

- The 2023 ASSP Leadership Conference will be held virtually on November 2.
- Safety 2024 Professional Development Conference & Exposition will be held in Denver, Colorado, August 7-9
- Safety 2025 Professional Development Conference & Exposition will be held in Orlando, Florida.
- We also have the BEST Conference in Raleigh in February 2024.
- Frieda shared the results from last week's PDC and presented the items that were discussed. She discussed the votes that passed.
  - SPY & Honor of Fellow Nominations Due by November 1, 2023
  - PayPal Chapter Use: We are to contact Mark Huelskamp and let him know if we are using PayPal or not for chapter business. There is an update for PayPal.
  - Common Interest Group (CIG) Liaison: If we are interested in having a CIG Volunteer Liaison to support our chapter, we should put a volunteer position on the Chapter website for Mark H. to fill. The Board will come up with a job description template.
  - \*Delegate position needed update on chapter website, but Chris Hinson took care of it.

#### **Region Assessment**

- Chapter Dues: It was voted on at the PDC for \$2 of each Chapter's dues to be allocated to the Regional Committee for the support of students attending the PDC, for ROC mtgs., disaster recovery efforts for impacted members, and to support travel for the regional committee members.
- This will be in effect April 1, 2024. Each chapter may decide on whether they will raise the dues \$2-5 to offset the regional assessment.
- Communications: we are encouraged to repost Region VI social media posts to our chapter pages so there isn't a lapse in communications.
- ECU: Needs a Faculty Advisor, Mike Behm is the new Dept. Chair for Construction Mgmt.

There is a list of Safety Schools in NC that will be added to our Chapter website to make members aware of opportunities for learning and networking.

Robin Barfield provided a brief update on the Advisory Board meetings. They hold frequent meetings to help transition from the House of Delegates to the Advisory Board construct. Concerning issue at this point is the UAW strike taking place in the US and the effects it will have on goods and services going forward.

### **Meeting Dates for Chapter Technical Meetings**

- The October Technical Meeting will be hybrid online / in-person meeting due to an influx in COVID cases heading into Fall.

  - Robin Barfield has a speaker lined up, and Grainger will speak on behalf of their sponsorship.
- Jon Wallace has a speaker available for November's Technical Meeting.

- Jon Wallace mentioned updates to the Electrical Standard, which could be used for December or January if we do not plan on having a Social Event.
- Doug reached out to Triad and Tar Heel regarding a joint meeting; Triad meets on the third Thursday, and Tar Heel is currently all in-person on the 1<sup>st</sup> Thursday of each month.
- The Tarheel Chapter is hosting a tour of the Krispy Kreme facility in Winston-Salem, which could be an opportunity to network with the other Chapters. Other Chapters are invited, let Doug know so he can provide a head-count.
- Doug Gaylord is working with the Tarheel and Triad Chapters for joint Technical Meetings. These will most likely be hybrid meetings due to the wider spread and locations.
